## **TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement (this "Agreement") is made and entered into effective November 20, 2016 (the "Effective Date") by and between Winter Harbor LLC a Connecticut limited liability company, having a place of business at 265 Franklin Street, 10<sup>th</sup> Floor, Boston, MA 02110 ("ASSIGNOR"), and Kitson Co., Ltd., a corporation incorporated under the laws of Japan, having a place of business at Bosch Bldg. Akasaka 4<sup>th</sup> Floor, 2-13-1 Nagatacho, Chiyoda-ku, Tokyo 100-0014, Japan ("ASSIGNEE").

### **RECITALS**

A. **WHEREAS**, ASSIGNOR and ASSIGNEE entered into that certain Asset Purchase Agreement (the "APA") of November 7, 2016 to effectuate a sale and transfer of ASSIGNOR's interest in trademarks and registrations listed on the attached Schedule A (the "Trademarks"), as well as any and all common law rights attached to the Trademarks which are owned by ASSIGNOR for the countries listed on Schedule B (the "Territory"); and

B. **WHEREAS**, ASSIGNOR and ASSIGNEE have agreed to enter into this Agreement to effectuate the transaction contemplated by the APA.

**NOW, THEREFORE**, in accordance with the foregoing recitals, and in consideration of the mutual covenants contained herein, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR and ASSIGNEE agree as follows:

### **ASSIGNMENT**

1. ASSIGNOR does hereby assign to ASSIGNEE, its successors and assigns, any and all interests of ASSIGNOR in and to the Trademarks, together with ASSIGNOR's good will of the business symbolized by the Trademarks and any applications and/or registrations therefor in the Territory, and the right, but not the obligation, to assert the Trademarks and to collect for all past, present, and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties, and proceeds of infringement suits, and all rights corresponding thereto by reason of any past and future acts of infringement that have occurred or may occur.

2. ASSIGNOR further covenants that ASSIGNEE will, upon its reasonable request, be provided promptly with all pertinent facts and documents relating to the Trademarks as may be known and accessible to ASSIGNOR and will testify as to the same in any litigation or other proceeding related thereto and will promptly execute and deliver to ASSIGNEE or its legal representatives any and all papers, instruments, certifications, powers of attorney, confirmatory assignments, declarations or affidavits necessary and appropriate to record and perfect the assignment and other rights granted herein in all applicable countries, and to maintain, enforce and exploit the Trademarks which may be necessary or desirable to carry out the purposes thereof. In the event that ASSIGNEE will seek testimony or other production of documents from ASSIGNOR in connection with any litigation or other proceeding to enforce the Trademarks, ASSIGNEE shall compensate ASSIGNOR at ASSIGNOR's then billing rates and costs associated thereto.
