**RELEASE OF SECURITY INTEREST UNDER TRADEMARK SECURITY AGREEMENTS**

This RELEASE OF SECURITY INTEREST UNDER TRADEMARK SECURITY AGREEMENTS (this "Trademark Release") is executed as of December 8, 2016 by JPMorgan Chase Bank, N.A., in its capacity as Administrative Agent under the Credit Agreement referred to below (in such capacity, the "Administrative Agent").


WHEREAS, pursuant to that certain Credit, Security, Guaranty and Pledge Agreement, dated as of September 25, 2000, as amended and restated as of December 15, 2003, as further amended and restated as of July 25, 2008, and that certain Third Amended and Restated Credit, Security, Guaranty and Pledge Agreement, dated as of September 27, 2012, and as amended by Amendment No. 1 on December 20, 2013 and as further amended by Amendment No. 2 on November 12, 2015 (the "Credit Agreement"), among the Grantors referred to therein, the Lenders referred to therein (the "Lenders") and Administrative Agent, the Lenders have agreed to make loans to Lions Gate Entertainment Corp. (the "Borrower") and the Issuing Bank has agreed to issue letters of credit for the account of the Borrower.

WHEREAS, in connection with the Credit Agreement, the Borrower is a party to (i) that certain Trademark Security Agreement dated as of September 25, 2000, as the same may be amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Original Trademark Agreement"), by and among the Borrower, the other Grantors party thereto and the Administrative Agent; (ii) that certain Amended and Restated Trademark Security Agreement dated as of December 15, 2003 (as the same may be amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Amended Trademark Agreement") (iii) that certain Second Amended and Restated Trademark Security Agreement dated as of July 25, 2008 (as the same may be amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Second Amended Trademark Agreement") by and among the Borrower, the other Grantors party thereto and the Administrative Agent; (iv) that certain Third Amended and Restated Trademark Security Agreement dated as of September 27, 2012 (as the same may be amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Third Amended Trademark Agreement") and (v) that certain Fourth Amended and Restated Trademark Security Agreement, dated as of December 20, 2013 (as the same may be amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Fourth Amended Trademark Agreement," and together with the Original Trademark Agreement, the Amended Trademark Agreement, the Second Amended Trademark Agreement and Third Amended Trademark Agreement, the "Trademark Agreements"), by and among the Borrower, the other Grantors party thereto and the Administrative Agent, pursuant to which the Grantors granted to the Administrative Agent a continuing security interest in and to the Trademark Collateral covered by the Trademark Agreements.
