WHEREAS, Globe Life desires to assign the Trademarks and the goodwill connected with the use of and symbolized by the Trademarks to Torchmark; and


WHEREAS, Globe Life is a wholly owned subsidiary of Torchmark.

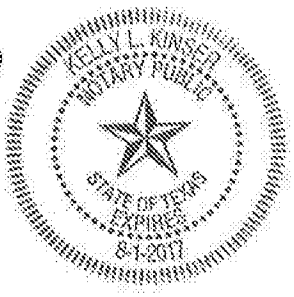


