**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is dated as of December 23, 2016 by Barclays Bank PLC, as Administrative Agent for the Secured Parties (in such capacity and together with its successors and permitted assigns, the “Administrative Agent”), in favor of Kaufman, Hall & Associates, LLC (the “Borrower” and a “Grantor”) and Axiom EPM LLC (a “Grantor” and together with the Borrower, the “Grantors”). All capitalized terms used but not otherwise defined herein have the meanings provided or provided by reference in the Security Agreement (as defined below).

**WHEREAS**, the Grantors, the other grantors party thereto and the Administrative Agent entered into a Security Agreement, dated as of December 31, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), pursuant to which the Grantors executed and delivered to the Administrative Agent that certain Trademark Security Agreement, dated as of December 31, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”);

**WHEREAS**, pursuant to the terms and conditions of the Security Agreement and the Trademark Security Agreement, each Grantor pledged to the Administrative Agent, its successors and permitted assigns, for the benefit of the Secured Parties, and granted to the Administrative Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest in, all right, title or interest in or to any and all of the Trademark Collateral (as defined in the Trademark Security Agreement), including all the registrations and applications listed in Schedule A attached hereto;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 31, 2014 at Reel 5433, Frame 0213 and at Reel 5433, Frame 0116; and

**WHEREAS**, the Administrative Agent desires to terminate and release the security interest in the Trademark Collateral.

**NOW, THEREFORE**, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates and releases the security interest in the Trademark Collateral, and retransfers and reassigns to the Grantors any right, title or interest of the Administrative Agent in or to the Trademark Collateral, without any recourse, representation or warranty whatsoever.
