TERMINATION OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION OF TRADEMARK SECURITY AGREEMENT**, dated as of October 20, 2016, is made by **CIT BANK, N.A.** (formerly known as OneWest Bank, FSB), as Administrative Agent (the “**Administrative Agent**”), in favor of **GLOBAL WIDE MEDIA, INC.**, a California corporation (the “**Grantor**”).

WHEREAS, Administrative Agent and Grantor are party to that certain Trademark Security Agreement, dated as of April 30, 2012 and recorded on September 6, 2012 at Reel/Frame number 4856/0976 in the United States Patent and Trademark Office (the “**Trademark Security Agreement**”; capitalized terms which are not defined herein have the meanings given to such terms in the Trademark Security Agreement), pursuant to which Grantor granted a continuing security interest to Administrative Agent in, and continuing lien, upon the trademarks and trademark applications, including, but not limited to, those shown on Exhibit A attached hereto, as security for certain obligations owing by Grantor to Administrative Agent pursuant to that certain Security Agreement, dated as of April 30, 2012, by and among Grantor, as borrower, the other grantors party thereto, and the Administrative Agent (the “**Security Agreement**”); and

WHEREAS, Grantor has requested that Administrative Agent release its security interest in, and continuing lien upon, the trademarks and trademark applications, including, but not limited to, those shown on Exhibit A, and reassign the same to the Grantor.

THEREFORE BE IT RESOLVED, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby discharges, terminates, cancels and releases any and all security interests in and lien on all of Grantor’s trademarks and trademark applications;

RESOLVED FURTHER, Administrative Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Administrative Agent, all of Administrative Agent’s right, title and interest in and to the trademarks and trademark applications, including any license and right to intellectual property pursuant to the Security Agreement;

RESOLVED FURTHER, Administrative Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Termination.


