## RELEASE OF IP SECURITY INTEREST

This Release of Security Interest (this "Release") is made as of December 22, 2016 by and between the Bank of Scotland plc, as agent and security trustee for itself and for each of the other Secured Parties ("Security Agent"), in favor of Clyde Bergemann, Inc., Clyde Bergemann Power Group Americas Inc., each, a Delaware corporation, and Clyde Bergemann Bachmann, Inc., a Maine corporation (together, the "Pledgor") and their respective successors, assigns and legal representatives.

WHEREAS, pursuant to that certain Guaranty and Collateral Agreement dated as of June 27, 2012 (the "Guaranty and Collateral Agreement"), among the Security Agent, Pledgor and lenders party thereto, the Pledgor executed and delivered to the Security Agent (i) that certain Trademark Security Agreement, dated as of June 27, 2012 (the "Trademark Security Agreement"), (ii) a supplement to the Trademark Agreement, dated as of January 31, 2013 ("Supplement No. 1"), and (iii) that certain Patent Security Agreement, dated as of June 27, 2012 (the "Patent Security Agreement"), in each case by and between the Pledgor and Security Agent (collectively, with the Guaranty and Collateral Agreement, the "Security Agreements");

Whereas, pursuant to the Security Agreements, the Pledgor granted and pledged to the Security Agent for the ratable benefit of the Secured Parties a security interest in and to all of the right, title and interest of the Pledgor, in and to the IP Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") as set forth at Reel 4815, Frame 0588 on July 5, 2012; Supplement No. 1 was recorded with the USPTO as set forth at Reel 4958, Frame 0539 on February 8, 2013; and the Patent Security Agreement was recorded with the USPTO as set forth at Reel 028502, Frame 0074; and

WHEREAS, each Pledgor has requested that the Security Agent enter into this Release in order to effectuate, evidence and record the release of any and all rights granted to Pledgors in the IP Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

SECTION 1 Defined Terms. Unless otherwise defined herein, capitalized terms used herein have the meaning given to them in the Guaranty and Collateral Agreement.

SECTION 2 Release of Security Interest. Security Agent, on behalf of each Pledgor, hereby terminates, releases and discharges any and all security interests, granted pursuant to the Security Agreements, in and to all of its right, title and interest in, to and under the IP Collateral, and hereby reassigns grants and conveys to each relevant Pledgor, without any representation, warranty, or further undertaking by the Security Agent, all of its right, title and interest, if any, granted pursuant to the Security Agreements, in and to the following (the "IP Collateral"):

(i) The Patents and Patent applications set forth on **Exhibit A** attached hereto, and all reissues, divisions, continuations, continuations-in-part, extensions, reexaminations and renewals of any of the foregoing;

(ii) The Trademarks and Trademark applications set forth on Exhibit B attached hereto, together with the goodwill connected with the use thereof and symbolized thereby, and all extensions and renewals of any of the foregoing, and

(iii) all proceeds of any and all of the foregoing.


SECTION 3. Recordation. Security Agent authorizes each Pledgor, or each Pledgor's authorized representative, to record this Release with the USPTO or any other governmental agency.

SECTION 4. Further Assurances. Security Agent agrees to take all further actions, and provide each Pledgor all such cooperation and assistance, including without limitation, to duly execute and deliver to each Pledgor any further documents and to do such other acts that each Pledgor (or its agents or designees) reasonably requests, at each relevant Pledgor's sole cost and expense, in order to confirm, effectuate or record this Release.

SECTION 5. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the State of New York without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).

IN WITNESS WHEREOF, Security Agent has caused this Release to be executed and delivered by its duly authorized officer as of the date hereof.
