**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

This Release of Security Interest (“Release”), effective as of the last dated signature below (the “Effective Date”), is entered into by and between SILICON VALLEY BANK, a California corporation (“Silicon Valley”) having a place of business at 380 Interlocken Crescent, Suite 600, Broomfield, Colorado 80021 and HEALTHX, INC., an Indiana corporation (“Healthx”) having its principal place of business at 9339 Priority Way West Drive, Suite 150, Indianapolis, Indiana 46240.

WHEREAS, Healthx granted a certain security interest in favor of Silicon Valley, effective April 23, 2015, which granted Silicon Valley a security interest in Intellectual Property Collateral (as defined in the April 23, 2015 Security Agreement), including but not limited to the trademark registration and application set forth on Schedule A, hereto (the “Trademarks”);

WHEREAS, Healthx has satisfied all obligations relating to the security interest granted to Silicon Valley; and

WHEREAS, the parties desire to confirm the release of the security interest;

NOW THEREFORE, in consideration of the foregoing recitals (which are incorporated into and made a part of this Release), the covenants set forth below and for other good and valuable consideration, the sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Release of Security interest. Silicon Valley hereby releases, terminates and extinguishes its security interest in and to the Intellectual Property Collateral, including but not limited to the Trademarks, and further disclaims any and all ownership interest in and to the Intellectual Property Collateral in favor of Healthx.

2. Further Assurances. Silicon Valley will take such further reasonable action as may be requested by Healthx to confirm the release of Silicon Valley’s security interest and to acknowledge Healthx’s ownership of all right, title and interest in and to the Intellectual Property Collateral, including but not limited to the Trademarks, at the sole cost and expense of Healthx.
