Termination of Security Interest

THIS TERMINATION OF SECURITY INTEREST (this "Termination"), dated as of December 20, 2016, is executed by BMO HARRIS BANK N.A., as administrative agent ("Administrative Agent"), in favor of MB PRECISION COMPANY, a Delaware corporation ("MB Precision") and MID STATE MACHINE PRODUCTS, a Maine corporation ("Mid State") and, together with MB Precision, collectively, the "Companies" and each, a "Company").

A. To secure the payment, performance, and observance of the Secured Obligations (as that term is defined in that certain Pledge and Security Agreement, dated as of January 23, 2014, executed by the Companies and the other entities party thereto as "Grantors" in favor of Administrative Agent (the "Security Agreement")), each Company granted to Administrative Agent a security interest, pursuant to that certain Trademark Security Agreement, dated as of January 23, 2014, executed by the Companies in favor of Administrative Agent and recorded with the United States Patent and Trademark Office (the "USPTO") on January 24, 2014 at Reel/Frame: 5200/0480 (the "Trademark Security Agreement"), in the Collateral (as defined in the Trademark Security Agreement), including, but not limited to, the trademarks set forth on Schedule 1 annexed to this Termination and made part of this Termination for all purposes (the "Trademarks").

B. Administrative Agent now wishes to terminate the security interest in the Collateral (as defined in the Trademark Security Agreement).

C. All capitalized terms used herein not otherwise defined herein have the meanings given to them in the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Administrative Agent, on behalf of the Credit Parties, without representation, warranty, or recourse, hereby:


1. terminates the Trademark Security Agreement;
2. terminates, cancels, discharges and releases any and all liens on and its security interest in and to the Collateral (as defined in the Trademark Security Agreement) arising under the Trademark Security Agreement, including, but not limited to, the Trademarks set forth on Schedule 1 annexed to this Termination; and
3. authorizes the recordation of this Termination by the Companies or any of their designees with the USPTO at each Company's expense.

THIS TERMINATION SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES.
