NOTICE OF RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (as amended, restated, supplemented or otherwise modified, this "Notice of Release"), effective as of December 22, 2016, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Administrative Agent (the "Administrative Agent").


