**RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARK
COLLATERAL**

This RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of December 27, 2016, by Jefferies Finance LLC, as collateral agent for the Secured Parties, (in such capacity, the "Collateral Agent"), in favor of Deltek, Inc., a Delaware Corporation (the "Pledgor"). Capitalized terms used and not defined herein have the meanings given such terms in the Security Agreement (as defined below).

WHEREAS, the Pledgor is a party to that certain Security Agreement, dated as of October 10, 2012, by and among the Pledgor, the Collateral Agent, and the subsidiary guarantors from time to time party thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "First Lien Security Agreement"), pursuant to which the Pledgor executed and delivered that certain First Lien Trademark Security Agreement, dated as of July 3, 2013 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "First Lien Trademark Security Agreement");

WHEREAS, pursuant to the First Lien Security Agreement and the First Lien Trademark Security Agreement, the Pledgor, as collateral security for the payment and performance in full of the Secured Obligations, pledged and granted to the Collateral Agent for the ratable benefit of the Secured Parties a Lien on and security interest in and to all of its right, title and interest in, to and under all of the following Pledged Collateral of the Pledgor, in each case excluding Excluded Property, whether then existing or thereafter arising or acquired from time to time: all trademarks (including service marks), slogans, logos, certification marks, trade dress, uniform resource locations (URLs), domain names, corporate names, trade names, or other indicia of source, whether registered or unregistered, all registrations and applications for the foregoing (whether statutory or common law and whether registered or applied for in the United States or any other country, multi-national registry or any political subdivision thereof), together with any and all (i) rights and privileges arising under applicable Legal Requirements with respect to the use of any of the foregoing, (ii) all goodwill associated therewith, (iii) extensions and renewals thereof and amendments thereto, (iv) proceeds, income, fees, royalties, damages and payments now and hereafter due and/or payable thereunder and with respect thereto, including damages, claims and payments for past, present or future infringements, dilutions or other violations thereof, (v) rights corresponding thereto throughout the world and (vi) rights to sue for past, present and future infringements, dilutions or other violations thereof, including the United States trademark registrations and applications for registration, listed on Schedule A attached hereto. (collectively, the "Trademark Collateral");

WHEREAS, the First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 7, 2013 at Reel 5086, Frame 0704; and

WHEREAS, the Collateral Agent acknowledges full performance of the Secured Obligations and has agreed to release the entirety of its security interest in the Trademark Collateral.


NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases and discharges its security interest in the Trademark Collateral, including, without limitation, the Trademarks referred to on Schedule A hereto, and re-assigns to the Pledgor any right, title or interest that the Collateral Agent may have in or to such Trademark Collateral, all without warranty or representation of any kind.

The Collateral Agent hereby authorizes the Pledgor, or the Pledgor's authorized representatives to: (a) record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Collateral Agent in the Trademark Collateral.
