AFFIDAVIT OF CHAIN OF TITLE

I, Cheryl L. Black, declare and state as follows:

1. My full name is Cheryl L. Black. I am in-house counsel for Plow & Hearth, LLC.
2. I am an adult over the age of 18 years and am competent to make this sworn statement.
3. I have personal knowledge of the facts regarding the ownership of U.S. Registration No. 4,022,352.
4. On January 25, 2010, PH International LLC changed its name from PH International LLC to Plow & Hearth, LLC ("Plow & Hearth").
5. On February 1, 2011, trademark application serial no. 85/230,960 for "HearthSong" in stylized lettering was filed with the United States Patent and Trademark Office ("USPTO"), naming Plow & Hearth as the applicant.
6. On February 10, 2011, a document dated February 9, 2011, assigning the trademark application serial no. 85/230,960 from Plow & Hearth, LLC to PH International, Inc. was recorded in the USPTO Assignment Branch. The reel/frame number of the recorded assignment is 4475/0883.
7. On November 7, 2011, a correction to the assignment recorded at reel/frame 4475/0883 on February 10, 2011 was filed and recorded with the USPTO Assignment Branch at reel/frame 4656/0435. The cover sheet stated that the original assignment contained typographical errors in the Assignee's name and entity type. The accompanying document assigned trademark application serial no. 85/230,960 from Plow & Hearth, LLC to PH International LLC.
8. The assignments recorded at 4475/0883 and 4656/0435 were filed in error because the assignment documents are invalid. The assignment from Plow & Hearth, LLC to PH International, LLC did not occur on February 9, 2011. Further, an assignment from Plow & Hearth, LLC to PH International LLC could not have occurred any time after January 25, 2010 inasmuch as the legal entity legally changed its name from PH International LLC to Plow & Hearth, LLC on January 25, 2010.

9. Since trademark application serial no. 85/230,960 was properly filed in the correct name of the entity, the application is valid. The assignment records should be corrected and updated to reflect the true owner of trademark application serial no. 85/230,96, now matured into U.S. Registration No. 4,022,352.

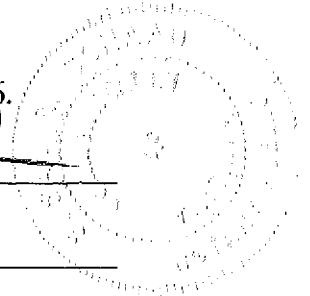

2. The Certificate of Formation of the Company is hereby amended by changing Article 1 to read as follows:


"First: The name of the limited liability company is Plow & Hearth, LLC."
