TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT ("Agreement") is entered into this 1 day of February, 2016, by and between H2W (previously known as "Worldwide Dynasty, Inc."), a corporation located at 20630 Superior Street, Chatsworth, CA 91311 ("Assignor"), and RC Jewels, Inc. located at 8775 Centre Park Drive #322, Columbia, MD 21045 ("Assignee").

WHEREAS, Assignor and Assignee entered into a Purchase Agreement, dated as of October 29, 2015 ("Purchase Agreement") wherein Assignor sold to Assignee, among other items, all of Assignor's rights, titles and interest in the domain name "www.icedoutgear.com," the website associated with the www.icedoutgear.com domain name, and intellectual property rights owned in association with the aforementioned website's operations; and

WHEREAS, Assignor owns the entire right, title and interest in and to U.S. Trademark Registration No. 3112977 ("Registration") for the mark ICED OUT ("Trademark"); and

WHEREAS, in accordance with the terms of the Purchase Agreement, Assignor desires to assign, and Assignee desires to acquire, the entire rights, title and interest in and to the Trademark, together with its corresponding Registration and the goodwill associated therewith.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained in the Purchase Agreement as well as in this Agreement, and for other good and valuable consideration, it is agreed between the parties as follows:

1. Assignor hereby transfers, assigns, sets over and conveys to Assignee, the entire right, title and interest in and to the Trademark and the Registration, as the successor to that portion of Assignor's business to which the Trademark pertains, along with all goodwill associated therewith.
2. Assignor hereby authorizes and requests that the U.S. Commissioner for Trademarks record Assignee as the owner of the Registration.
3. This Agreement, together with the Purchase Agreement, constitutes the entire agreement between the parties and supersedes any prior understandings, agreements, or representations by or between the parties, written or oral, to the extent they relate in any way to the subject matter hereof.
4. Any term or provision of this Agreement that is invalid or unenforceable in any situation in any jurisdiction shall not affect the validity or enforceability of the remaining terms and provisions hereof or the validity or enforceability of the offending term or provision in any other situation or in any other jurisdiction.


