FIRST SUPPLEMENT TO AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

This First Supplement to Amended and Restated Trademark Security Agreement (this "First Supplement") is made as of the 20th day of December, 2016 by YOUNG DENTAL MANUFACTURING I, LLC, a Missouri limited liability company ("Grantor"), in favor of GOLUB CAPITAL MARKETS LLC, in its capacity as Agent ("Grantee") for the credit parties under the Security Agreement (defined below).

WHEREAS, reference is made to that certain (a) Amended and Restated Guarantee and Collateral Agreement, dated as of October 18, 2016 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), entered into by, among others, Grantor and the Grantee, and (b) Amended and Restated Trademark Security Agreement dated as of October 18, 2016 and recorded on October 18, 2016 at Reel 5904, Frame 0359 (the "Existing Grant");;

WHEREAS, pursuant to the Security Agreement, as further evidenced by the Existing Grant, the Grantor has granted a security interest to the Grantee in, among other things, the Trademarks; and


WHEREAS, the Grantor desires to hereby confirm the pledge of, and the grant of a security interest in, an additional Trademark in favor of the Grantee.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Existing Grant.
2. Supplement to Schedule A. Schedule A to the Existing Grant is hereby supplemented, but not replaced, by Schedule A-1 annexed hereto. For the purposes of clarity, from and after the date hereof, Schedule A shall be deemed to include (i) the Trademarks referenced on Schedule A as such Schedule A exists immediately prior to the date hereof and (ii) the Trademark referenced on Schedule A-1 annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the Existing Grant remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - b. This First Supplement and the Grant cover the entire understanding of the parties with respect to the matters set forth herein and supersede all prior discussions and negotiations hereon.
