**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of December \_\_, 2016 (the "Effective Date") by U.S BANK TRUSTEES LIMITED, as security agent for the Secured Parties ("Grantee"), in favor of TREND DESIGN SHOE FASHION B.V. (f/k/a New Trend Design B.V.), a private company with limited liability organized under the laws of the Netherlands ("Grantor").

**WHEREAS**, Grantee's continuing security interest in the Trademarks is evidenced by the filing of that certain Trademark Security Agreement, by and between Grantor and Grantee dated February 6, 2015 (the "Trademark Security Agreement"), and recorded with the United States Patent and Trademark Office (the "PTO") on February 12, 2015 at Reel/Frame 005458/0764.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:



Grantee hereby terminates, cancels and releases any and all security interests it has against the Trademarks granted pursuant to the Security Agreement and the Trademark Security Agreement and releases all other rights it may have to the Trademarks under the Security Agreement and the Trademark Security Agreement.
2. Grantee, to the extent granted in the Security Agreement or the Trademark Security Agreement, hereby assigns, grants and otherwise re-conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of its right, title and interest in and to the Trademarks and all goodwill associated therewith originally granted to Grantee pursuant to the Security Agreement or the Trademark Security Agreement.
3. Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release and authorizes the Grantor (or its designees) to have this Release recorded with the PTO.


