- c. to perform all affirmative acts which may be necessary to obtain registration, maintenance or renewal of a valid United States or foreign Trademark / Service Mark to the Assignee on any of the Intellectual Property and on any reexamination of any of the Intellectual Property.

interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.


