**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**


WHEREAS, Penda Corporation, a Delaware corporation, The Fabri-Form Company, an Ohio corporation, Durakon Industries, Inc., a Michigan corporation, and Durakon Acquisition Corp., a Michigan corporation (collectively, the "Companies" and each, a "Company") entered into (i) a Security and Pledge Agreement, dated as of July 26, 2013 (as from time to time amended, modified or supplemented, the "Security Agreement") by the Companies and certain of their affiliates in favor of KeyBank National Association, as administrative agent (the "Administrative Agent") for the holders of the Secured Obligations referenced therein and (ii) a Notice of Grant of Security Interest in Trademarks, dated as of July 26, 2013 (as from time to time amended, modified or supplemented, the "Trademark Agreement" and, together with the Security Agreement, the "Agreements") by the Companies in favor of the Administrative Agent, pursuant to which each Company granted a security interest (the "Security Interest") in all of such Company's right, title and interest in and to the Trademarks (as defined in the Security Agreement), including without limitation the trademarks and trademark applications set forth on the attached Schedule A, all to the extent set forth in the Agreements; and

WHEREAS, all of the secured obligations have been fully paid and satisfied and the Administrative Agent desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases the Security Interest in the Trademarks listed on Schedule A annexed hereto, and hereby, (i) waives and relinquishes all its rights, powers, privileges and remedies under the Agreements with respect to the Trademarks, (ii) assigns, conveys, transfers and sets over to the applicable Company any right, title or interest that the Administrative Agent may have acquired and re-vests in the applicable Company the full unencumbered title to the Trademarks and the goodwill associated therewith, and (iii) releases each Company from all covenants, obligations, liabilities and warranties under the Agreements related to the Trademarks.
