## DEED OF ASSIGNMENT

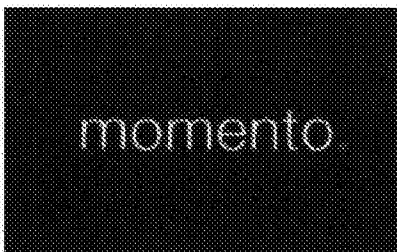
### PARTIES:
