RELEASE OF SECURITY INTEREST IN TRADEMARKS

December 30, 2016

WHEREAS, GOLDMAN SACHS BANK USA, in its capacity as collateral agent (“**Collateral Agent**”) for certain lenders, a New York chartered bank with an office at 6011 Connection Drive, Irving, Texas 75039, **CYNERGY DATA, LLC**, a Delaware limited liability company with an office at 4800 North Point Parkway, Suite 100, Alpharetta, Georgia 30022, and **PRIORITY PAYMENT SYSTEMS LLC**, a Georgia limited liability company, with an office at 2001 Westside Parkway, Suite 155, Alpharetta, Georgia 30004 (each, a “**Grantor**” and collectively, the “**Grantors**”), entered into that certain Trademark Security Agreement, dated as of May 21, 2014 (the “**Trademark Security Agreement**”), notice of which was recorded on May 23, 2014, in the Trademark Division of the United States Patent and Trademark Office at Reel/Frame 5285/0963.

WHEREAS, Grantors granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing First Priority security interest (the “**Security Interest**”) in all of each Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Collateral Agent has agreed to terminate and release its Security Interest in all the Trademark Collateral (including, without limitation, with respect to the Trademarks and Trademark Licenses referred to on Schedule A, attached hereto) as provided herein.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the Lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in all of each Grantor’s right, title and interest in, to and under the Trademark Collateral, including the Security Interest, and assigns and conveys to Grantors any right, title and interest it may have acquired in, to and under the Trademark Collateral, and authorizes and directs the United States Patent and Trademark Office to note and record the existence of such release hereby given.

All capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Trademark Security Agreement.

This Release of Security Interest in Trademarks is effective as of the date first written above.
