RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the “Release”), dated as of December 30, 2016, is made by BNP PARIBAS, as Administrative Agent for the Lenders (the “Secured Party”), pursuant to the Credit Agreement, dated as of November 1, 2016, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) and the Security Agreement, dated as of November 1, 2016, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”).

WITNESSETH

WHEREAS, BROCK WHITE COMPANY, LLC (the “Grantor”) is a party to the Security Agreement;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Secured Party that certain Grant of Trademark Security Interest, dated as of November 1, 2016 (the “Trademark Security Agreement”) and recorded with the United States Patent and Trademark Office on November 1, 2016 at Reel/Frame No. 5912/0771, pursuant to which the Grantor granted to the Secured Party a security interest in all of its right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, as of the date hereof, all of the obligations secured by the security interest granted under the Trademark Security Agreement have been paid, performed, satisfied and discharged in full and, in connection therewith, the Grantor has requested that the Secured Party release its security interest in all of its right, title and interest in and to the Trademark Collateral.


