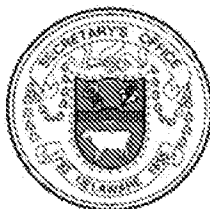

This Certificate of Conversion to Limited Liability Company, dated as of December 7, 2016, has been duly executed and is being filed by NewPage Corporation, a Delaware corporation (the "Corporation"), to convert the Corporation to NewPage LLC, a Delaware limited liability company (the "LLC") under the General Corporation Law of the State of Delaware (8 Del. C. § 101, et seq.) and the Delaware Limited Liability Company Act (6 Del. C. § 18-101, et seq.).

1. The Corporation filed its original certificate of incorporation with the Secretary of State of the State of Delaware and was first incorporated on January 28, 2005 in the State of Delaware, and was incorporated in the State of Delaware immediately prior to the filing of this Certificate of Conversion to Limited Liability Company.

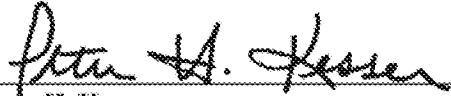
3. The name of the LLC into which the Corporation shall be converted as set forth in its certificate of formation is NewPage LLC.
