**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of December 30, 2016, from WILMINGTON TRUST, NATIONAL ASSOCIATION (successor by merger to Wilmington Trust FSB), a national banking association located at 50 South Sixth Street, Suite 1290, Minneapolis, Minnesota 55042, as Collateral Trustee (the "Collateral Trustee") for the Secured Parties (as defined in the Notes Security Agreement), to ATLANTIC DIVING SUPPLY, INC. (the "Grantor"), a Virginia corporation located at 621 Lynnhaven Parkway, Suite 400, Virginia Beach, VA 23452.

WITNESSETH:

WHEREAS, pursuant to the Notes Security Agreement, dated as of March 25, 2011 (as amended, modified, extended or restated from time to time), by and among ADS Tactical, Inc. ("Holdings"), the Grantor and certain other Subsidiaries of Holdings from time to time party thereto, as Guarantors, and the Collateral Trustee (the "Notes Security Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Collateral Trustee, for the benefit of the Secured Parties, in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks, dated as of June 29, 2015, (the "Trademark Security Agreement"), the Grantor, by reference to the Notes Security Agreement, reaffirmed its intent to grant a Security Interest to the Collateral Trustee specifically in certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 30, 2015, at Reel 5565 and Frame 0515;

WHEREAS, pursuant to the written request of the Grantor, and in connection with the satisfaction and discharge of the Indenture dated as of March 25, 2011 by and among Holdings, the guarantors party thereto, Wilmington Trust, National Association, as Trustee and the Collateral Trustee (the "Indenture"), the Collateral Trustee now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral; and

WHEREAS, on the date hereof, the Collateral Trustee has received an Officer's Certificate and an Opinion of Counsel each stating that all conditions precedent under the Indenture to the execution of this Termination and Release by the Collateral Trustee have been satisfied.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Notes Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Trustee hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the

Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Notes Security Agreement and the Trademark Security Agreement.

2. Release of Security Interest. The Collateral Trustee hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Collateral Trustee in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Collateral Trustee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

4. Recordation. The Collateral Trustee authorizes and requests that the Commissioner for Trademarks at the United States Patent and Trademark Office or any other applicable government officer record this Termination and Release.


