NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, Assignor does hereby assign unto Assignee all of Assignor's right, title and interest in and to the Trademarks and the registrations and applications therefor in the United States, the State of Texas, and throughout the world together with all common law rights related thereto, with the goodwill of the business symbolized by the Trademarks, along with the right to sue and recover for, and the right to profits, penalties or damages due or accrued arising out of or in connection with any and all past, present and future infringements or dilution of or damage or injury to the Trademarks or such represented goodwill;

Assignor agrees to execute and deliver at the reasonable request of the Assignee, all papers, instruments, and assignments, and to perform other acts the Assignee reasonably may require in order to vest all Assignor's right, title and interest in and to the Trademarks in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence reasonably is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of the Assignor.

Assignor authorizes the Commissioner of Trademarks of the United States, the Texas Secretary of State, and other empowered officials of the United States Patent and Trademark Office and the State of Texas, and in any applicable jurisdictions outside the United States to record the transfer of the registrations and/or applications for registration of the Trademarks to Assignee as assignee of Assignor's entire right, title and interest therein.
