TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Agreement") dated as of December 30, 2016, from Robb Media Intermediate Holdings, LLC, a limited liability company of Delaware (together with its successors and assigns in such capacity "Successor Secured Party"), in favor of CurtCo Robb Media, LLC, a limited liability company of Delaware; ("Grantor").

WITNESSETH:

WHEREAS, Grantor is a party to a certain Amended and Restated Security Agreement, dated as of May 3, 2012 by Grantor in favor of Successor Secured Party, as successor secured party to Robb Media Intermediate Holdings, LLC, as successor agent to Robb Media Investors, LLC, as successor agent to General Electric Capital Corporation, as agent and the Trademark Security Agreement by Grantor in favor of Successor Secured Party, as successor secured party to Robb Media Intermediate Holdings, LLC, as successor agent to Robb Media Investors, LLC, as successor agent to General Electric Capital Corporation, as agent;

WHEREAS, Grantor in its capacity as Borrower and Successor Secured Party entered into a Second Amended and Restated Credit Agreement dated November 25, 2014 ("Credit Agreement") and a Secured Party Transition Agreement dated November 25, 2014, ("Transition Agreement") wherein the role of agent under the Credit Agreement was eliminated and vested all rights, powers, privileges and duties of the agent to the Successor Secured Party;

WHEREAS, in connection with the Trademark Security Agreement and the Transition Agreement, the Successor Secured Party was granted a security interest in all of each Grantor's right, title and interest in, to and under all Trademark Collateral (as described on the attached as Schedule A) from the Grantor (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Trademark Security Agreement);

WHEREAS, the Substitution of Secured Party from Robb Media Intermediate Holdings, LLC in favor of Successor Secured Party was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (the "USPTO") on November 25, 2014 at Reel 5409 and Frame 0248; and
