## **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (the "Release") is made as of December 27, 2016 (the "Effective Date"), from ALLY COMMERCIAL FINANCE LLC, a Delaware limited liability company ("Assignee") to AMERICAN DRIVELINE SYSTEMS, INC., a Delaware corporation (successor by merger to Cottman Transmission Holdings, LLC (successor by merger to Cottman Midco, LLC)); AAMCO TRANSMISSIONS, INC., a Pennsylvania corporation (successor by merger to Accel Advertising, Incorporated); AMERICAN DRIVELINE CENTERS, INC., a Pennsylvania corporation; AMERICAN DRIVELINE TECHNICAL SERVICES CORPORATION (formerly known as AMERICAN DRIVELINE COMMUNICATIONS CORP.), a Pennsylvania corporation; GLOBAL POWERTRAIN SYSTEMS, LLC, a Delaware limited liability company; COTTMAN TRANSMISSION SYSTEMS, LLC, a Delaware limited liability company (successor by merger to Select-Trans Equipment Co. and Cottman Management Corporation (successor by merger to Horsham Leasing Company)); COTTMAN MANAGEMENT CORPORATION, a Pennsylvania corporation; and ROSS ADVERTISING, INC., a Pennsylvania corporation (collectively, the "Assignors").

### **RECITALS**

**WHEREAS**, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement, dated as of February 17, 2012, by and between certain of the Assignors and Assignee (the "First Security Agreement"), and that certain Intellectual Property Security Agreement, dated as of March 25, 2015, by and between Assignors and Assignee (the "Second Security Agreement" and together with the First Security Agreement, the "Security Agreements"), Assignors granted to Assignee a security interest in and to all of Assignors' respective right, title and interest in and to (1) the United States trademark and service mark registrations and applications set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith; and (2) the United States copyright registrations set forth on Schedule B attached hereto (collectively, the "Intellectual Property Collateral").

**WHEREAS**, the First Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on February 22, 2012, at Reel/Frame: 4721/0708;

**WHEREAS**, the Second Security Agreement was recorded with the USPTO on March 27, 2015, at Reel/Frame: 5487/0309; and

**WHEREAS**, Assignee now desires to terminate and release the entirety of its security interest in the Intellectual Property Collateral and any other trademark registrations and applications and copyright registrations and applications owned by any of the Assignors against which it has a security interest (such registrations and applications together with the Intellectual Property Collateral, the "Released IP");

**NOW, THEREFORE**, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Released IP pursuant to any security agreements between the Assignors and Assignee (including the Security Agreements), the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release:


1. Assignee hereby terminates, cancels, releases, and discharges any and all security interests in the Released IP, and any right, title or interest of Assignee in and to such Released IP shall hereby cease and become void.
2. Assignee hereby authorizes and directs the Commissioner of the USPTO to record this Release.
3. Assignors and Assignee hereby agree that this Release may be executed in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original, but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page of this Release by facsimile or email shall be as effective as if the original signature had been delivered to the other party.
4. Assignors and Assignee hereby agree that this Release shall be governed by and construed in accordance with the laws of the State of New York without regard to principles of conflicts of law.
