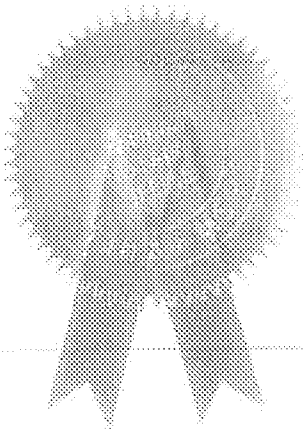

Stock Options

F. The Company may grant stock options under certain conditions.

The Company may, by a special resolution of the general meeting of shareholders, grant stock options to its directors, statutory auditors or employees to the extent of not exceeding 10/100 of the Company's total number of issued and outstanding shares.

1. Type and number of shares to be issued or transferred upon exercise of stock options

The share to be delivered upon exercise of stock options (or if the difference between the share price at which such stock options are exercised and the market value of relevant share is paid in cash or treasury share, the share on the basis of which such difference is calculated) shall be determined by a resolution of the general meeting of shareholders or the meeting of board of directors, which grant the stock options, of the shares set forth in Article 9.

1. Qualifications of those whom have been granted stock options

Stock options may be granted to those who have contributed, or are capable of contributing, to the incorporation, management, and technological innovation of the Company, except for any person who falls under any of the following:

1. A shareholder who holds 10/100 or more of the total number of issued and outstanding shares of the Company excluding non-voting shares;
2. A person who actually has influence or control over major management related matters of the Company such as the appointment or dismissal of directors and statutory auditors; and
3. Spouse and lineal ascendants or descendants of the person falling under subparagraphs 1 and 2 above.

1. Exercise period of stock options

Stock options may be exercised within five (5) years from the date after two (2) years have elapsed from the date when the resolution set forth in Paragraph (1) above is adopted; provided, however, that in such case, a person who has been granted stock options is entitled to exercise the stock options only if he/she has been in office in the Company or employed by the Company at least for two (2) years from the date when the resolution set forth in Paragraph (1) is adopted.

1. The Company may cancel the grant of stock options by a resolution of the meeting of board of directors under certain conditions.

The Company may cancel the grant of stock options by a resolution of the meeting of board of directors under any of the following circumstances:

- a. where the director, statutory auditor or ~~employee~~ who has been granted stock options resigns or retires on his/her own volition;
- b. where the director, statutory auditor or employee who has been granted stock options causes substantial damage to the Company intentionally or by negligence;
- c. where stock options cannot be exercised due to bankruptcy, dissolution, etc. of the Company; or
- d. where any of the reasons for cancellation set forth in the stock option agreement comes to existence.

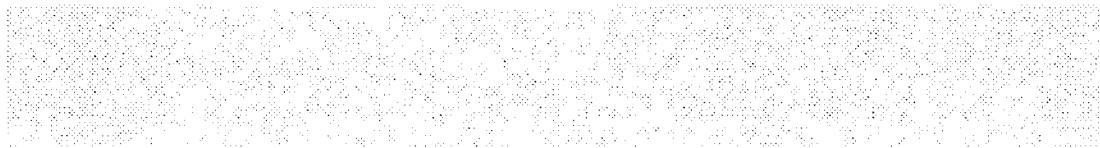

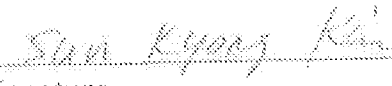
