## DECLARATION OF NOEL CHEROWBRIER

I, Noel Cherowbrier, declare and state as follows:

1. I am the Chief Executive Officer for T3 Motion, Inc. ("T3"). I submit this declaration pursuant to TMEP § 503.06(c) to correct the assignments recorded for U.S. Trademark Registration Nos. 3,644,299, 3,511,123 and 3,901,825 (collectively referred to as "Trademarks").
2. T3 has been and continues to be the sole and correct owner of the Trademarks.
3. A document with erroneous assignment information was recorded at Reel/Frame 005591/0325. The document dated August 3, 2015 purports to be an assignment of Lender Collections LLC's ("Lenders") rights to the Trademarks in satisfaction of a default by a security agreement entered by and between T3 and several institutional and individual accredited investors.
4. The purported default of the security agreement and subsequent assignments of the Trademarks to Lenders were orchestrated by Mr. William Tsumpes in attempt to defraud T3 of its Trademarks among other things shortly before his ouster as CEO of T3.
5. The purported assignment of T3's rights to the Trademarks to Lenders is ineffective. In July 2015, Tsumpes was removed as a director and officer of T3 and stripped of any authority to act on behalf of T3, pursuant to orders entered in the matter of entitled *Elite Horse Investments, Ltd. v. T3 Motion, Inc.*, Del. Chancery Court C.A. No. 10550-CB, which is attached as Exhibit A.
6. T3 has also filed a complaint against Tsumpes, Lenders, and other related entities in Orange County Superior Court, entitled *T3 Motion, Inc. v. William Tsumpes, et al.* (Case No. 30-2015-00817371-CU-FR-CJC), asserting claims for breach of fiduciary duty, fraud and constructive fraud, conversion, constructive trust, and declaratory relief, which is attached as Exhibit B.
7. On November 25, 2015, Lenders filed a complaint against T3 in New York State

Court asserting breach of contract under the security Agreement. T3 alleges that the purported assignments are void as champertous and has filed counterclaims for, *inter alia*, declaratory relief arising out of T3's purported assignment. The case is currently pending in Supreme Court in the State of New York, County of New York (Case No. 653920/2015).

I do hereby state and declare that all statements made herein of my own knowledge are true and all statements made on information and belief are believed to be true, and these statements were made with the knowledge that willful false statements are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001.
