

SECURITY AGREEMENT



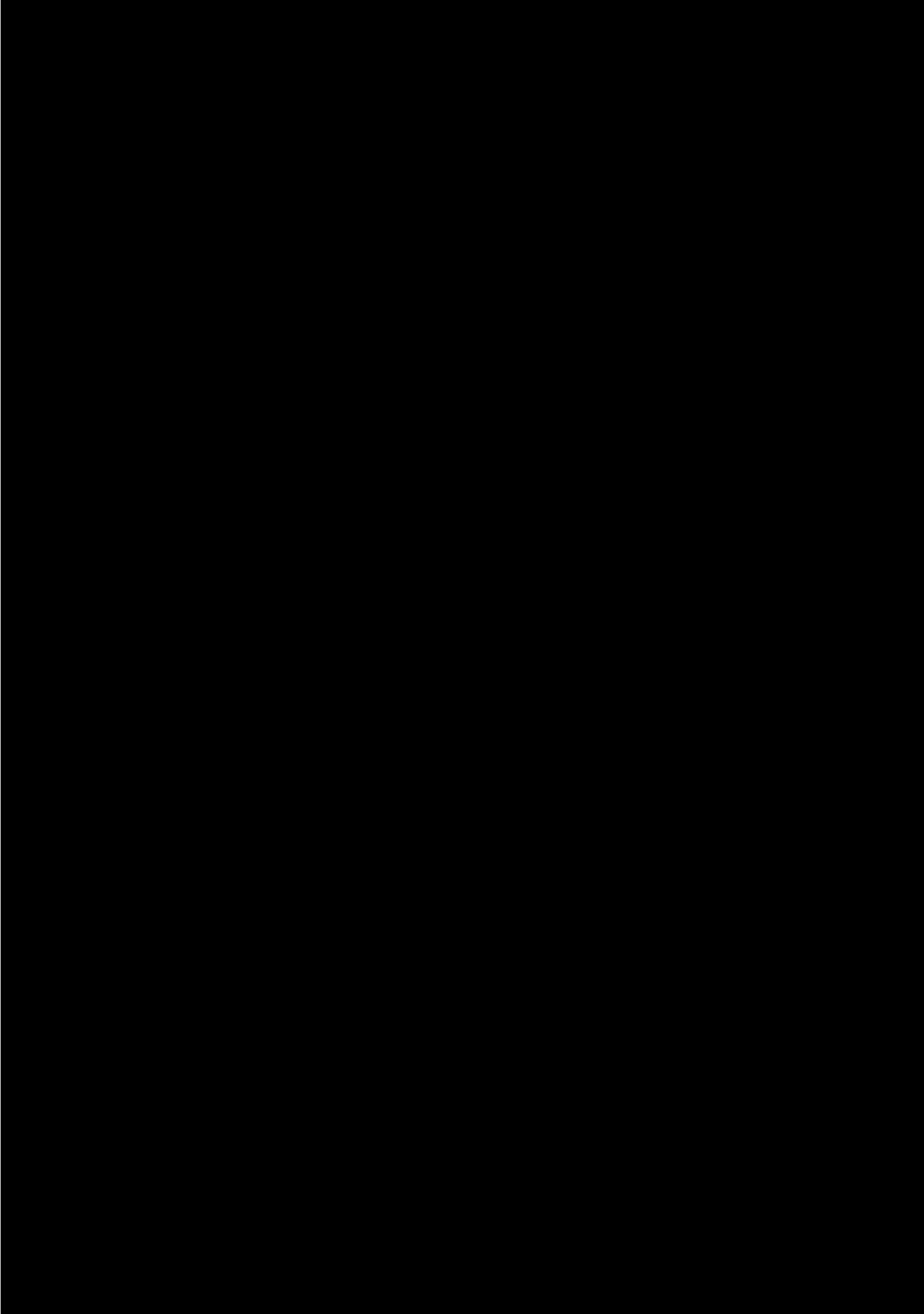
(a) all of the Issuer’s ownership interests in each of MedTech Catalyst, LLC and MedTech Catalyst 2, LLC; and

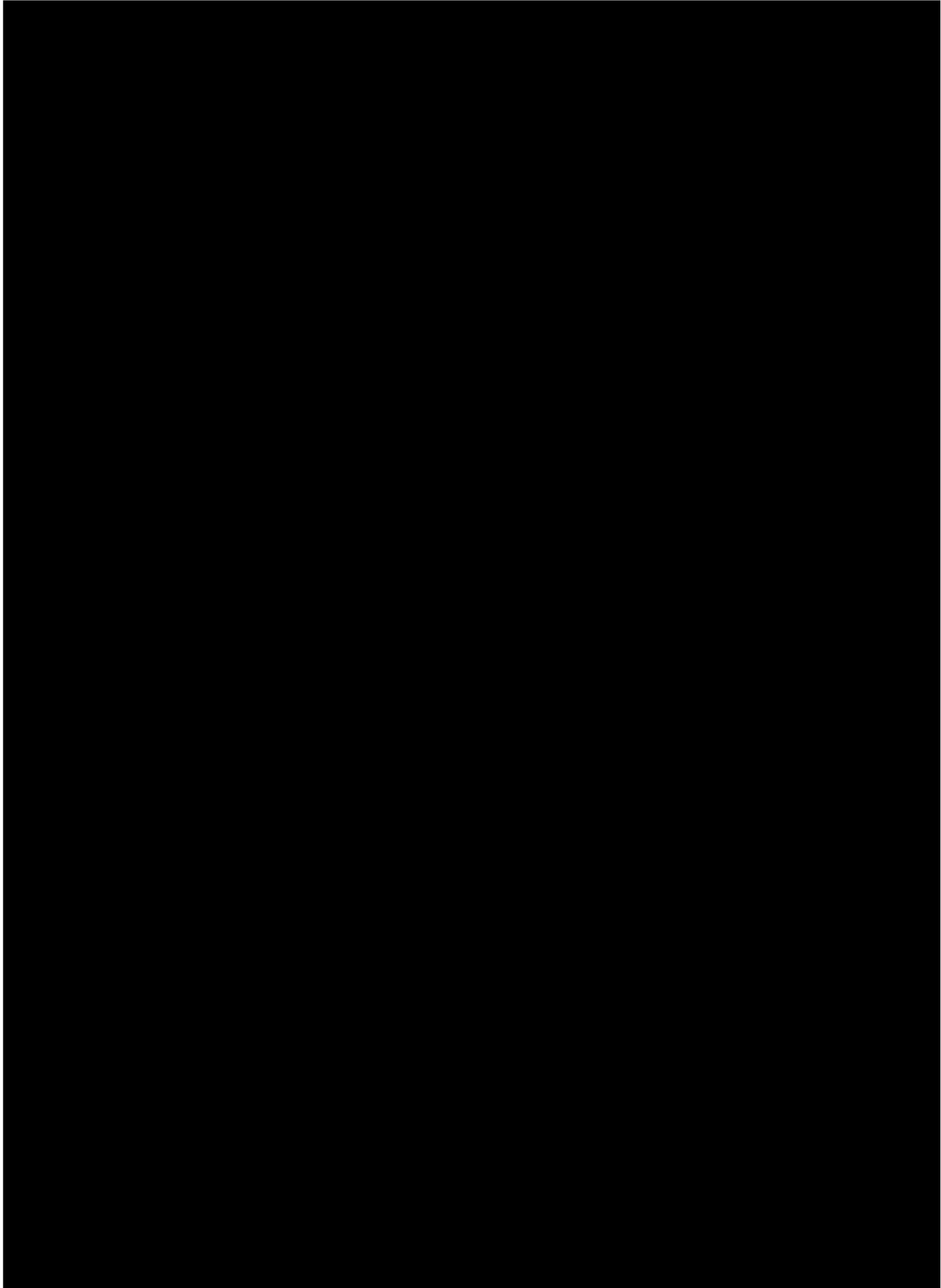

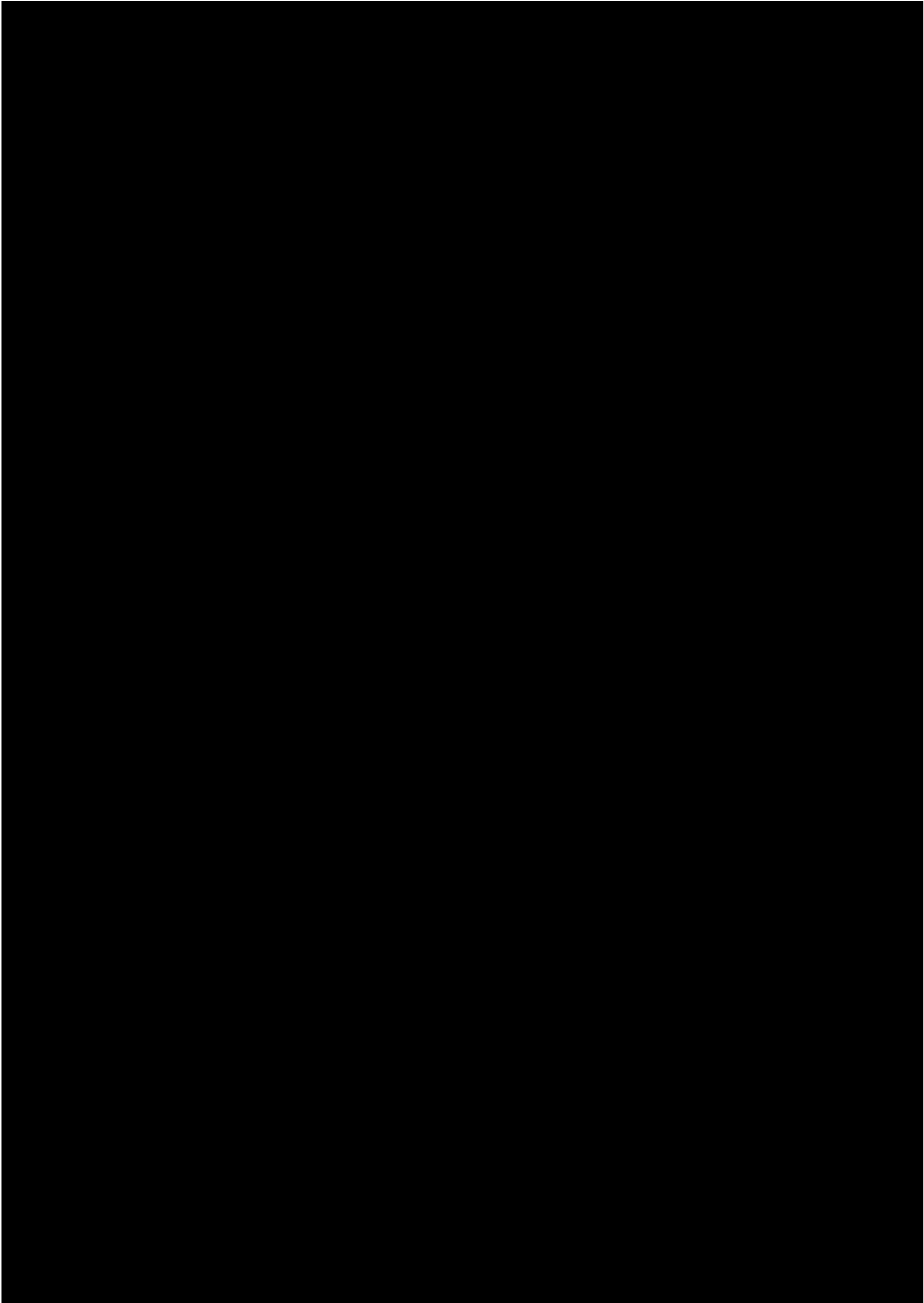

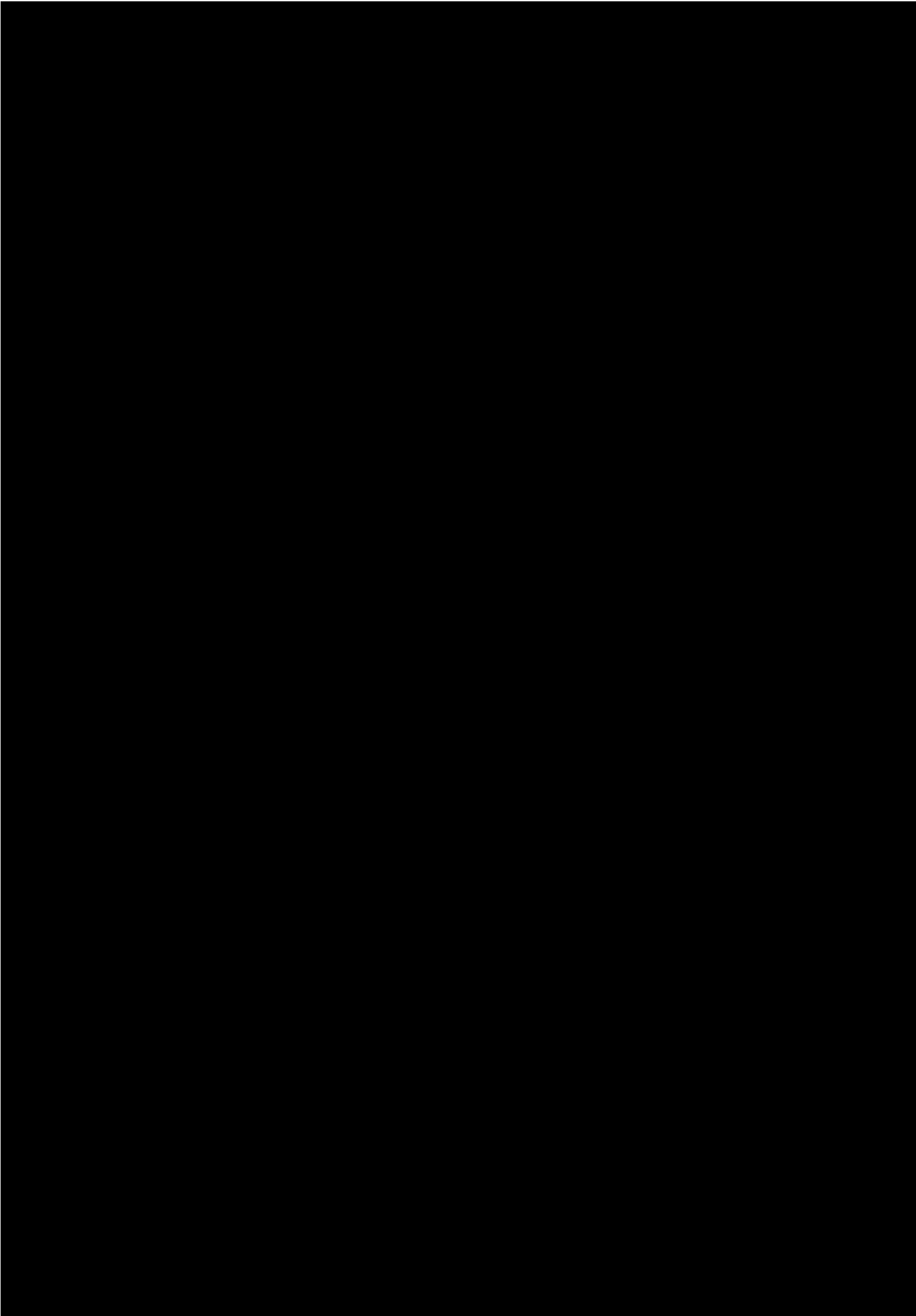
