**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK COLLATERAL**

This Termination and Release (this "*Release*") is made with regard to that certain Intellectual Property Security Agreement entered into as of March 25, 2014 (the "*Agreement*") by and between HIGHLAND CONSUMER FUND I LIMITED PARTNERSHIP, HIGHLAND CONSUMER FUND 1-B LIMITED PARTNERSHIP and HIGHLAND CONSUMER ENTREPRENEURS FUND I LIMITED PARTNERSHIP, each a Delaware limited partnership (each a "*Lender*" and collectively, the "*Lenders*") and TRUPANION, INC., a Delaware corporation (the "*Company*").

WHEREAS, pursuant to the Agreement, which was recorded on March 26, 2014 at Reel 005244 Frame 0587 in the U.S. Patent and Trademark Office, the Company granted the Lenders a security interest (the "*Security Interest*") in certain Intellectual Property Collateral, as defined in the Agreement, including the trademarks listed in Trademark Schedule A hereto (the "*Trademarks*").

WHEREAS, the Company has been discharged in full all of its obligations (as defined in the Agreement) under the Agreement, and the parties desire to enter into this Release to confirm that the Lenders have released the security interests in and to the Intellectual Property Collateral and the parties desire to enter into this Release to confirm this fact and to expunge any recordation of the Security Interest insofar as it pertains to the Intellectual Property Collateral.

NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lenders forever release and discharge the entire Security Interest in and to all of the Intellectual Property Collateral, including the Trademarks, granted to the Lenders by the Agreement.

The Lenders hereby agree to execute such instruments, to take such other actions, and to give such further assurances as the Company reasonably shall request to terminate any security interest in the Intellectual Property Collateral pursuant to the Agreement and otherwise to effectuate the release of all recordations of such Security Interest.

The Lenders acknowledge and agree that the Company and its successors and assigns may rely upon this Release. Each Lender represents and warrants that it has not transferred or assigned all or any part of the Security Interest in the Intellectual Property Collateral to any third party, and that it has all necessary authority to execute this Release and grant the releases and discharges and all other rights set forth herein.

IN WITNESS WHEREOF, the Lenders have caused this Release to be executed by a duly authorized officer thereunto.
