**FIRST:** The Corporation owns 100% of the capital stock of GeoEye Solutions HoldCo Inc., a corporation originally incorporated on the 31<sup>st</sup> day of October, 2005 under the name Orbimage SI HoldCo Inc., pursuant to the provisions of the Delaware General Corporation Law of the State of Delaware and that the Corporation, by a resolution of its Board of Directors via unanimous written consent effective as of September 25, 2015, determined to and did merge into itself said DigitalGlobe, Inc., which resolution is in the following words to wit:

obligations, and the date of adoption thereof, and to file the same in the office of the Secretary of State of Delaware;
