RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF COLLATERAL


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby:

1. releases, terminates, discharges and reassigns to Debtor any and all liens, security interests, right, title and interest of Lender pursuant to the Security Agreement, including but not limited to, the IP Collateral described in **Schedule A** annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, and hereby terminates the Security Agreement, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Debtor to Lender pursuant to or in connection with the Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.

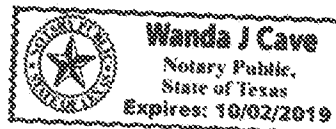
