**PARTIAL RELEASE
OF SECURITY INTEREST IN SPECIFIED TRADEMARKS**

This **PARTIAL RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARKS** (this "Release"), dated as of January 6, 2017 (the "Effective Date"), is made by BANK OF AMERICA, N.A., in its capacity as administrative agent (the "Administrative Agent"), in favor of ANVIL INTERNATIONAL, LLC (the "Grantor").

WHEREAS, pursuant to that certain ABL Pledge and Security Agreement, dated as of November 25, 2014, by and among the Administrative Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Security Agreement"), the Grantor collaterally assigned, granted, mortgaged and pledged to the Administrative Agent, in its capacity as Administrative Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered: (i) ABL Trademark Security Agreement, dated as of November 25, 2014 and recorded with the United States Patent and Trademark Office (the "USPTO") on December 1, 2014, at Reel 5409, Frame 0683, (ii) ABL Trademark Security Agreement, dated as of November 25, 2014 and recorded with the USPTO on December 1, 2014, at Reel 5409, Frame 0794, and (iii) ABL Trademark Security Agreement, dated as of November 25, 2014 and recorded with the USPTO on December 1, 2014, at Reel 5409, Frame 0748 (collectively, the "Trademark Security Agreements");

WHEREAS, in reliance of the Grantor's representations and warranties concerning the transactions referenced in that certain Confirmation of Partial Release, dated as of January 6, 2017, the Administrative Agent has agreed to release, discharge, terminate and cancel its security interest in certain specified collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.

2. Release of Specified Collateral. The Administrative Agent, without representation or warranty of any kind, hereby (i) releases, discharges, terminates and cancels all of its security interest arising under the Trademark Collateral (as defined in the Security Agreement) in the trademark registrations and applications set forth on Schedule 1 attached hereto (the "Released Trademark Collateral"), and (ii) terminates the Security Agreement and Trademark Security Agreements solely with respect to the Released Trademark Collateral. If and to the extent that the Administrative Agent has acquired any right, title or interest in and to the Released Trademark Collateral under the Trademark Security Agreements, the Administrative Agent, without representation or warranty of any kind, hereby transfers, conveys and assigns such right, title or interest to the Grantor.

3. Limitation. This Release is applicable only and solely with respect to the Released Trademark Collateral and to no other Trademark Collateral or any other collateral arising under the Security Agreement or the Trademark Security Agreement (the "Retained Collateral"). The Administrative Agent retains all security interests, liens, rights, titles and interests collaterally assigned, granted, mortgaged and pledged to the Administrative Agent under the Security Agreement and the Trademark Security Agreement with respect to all such Retained Collateral, and the Administrative

Agent's security interest, liens, rights, titles and interests in such Retained Collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Release.

4. Further Assurances. The Administrative Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.


5. Recordation. The Administrative Agent hereby authorizes Anvil International, LLC or any of its authorized representatives to file this Release with the USPTO or any other applicable governmental office. The Administrative Agent hereby further authorizes and requests an applicable government officer record this Release.

6. Governing Law. This Release shall be governed exclusively under the laws of the state of New York, without regard to conflicts of law or choice of law principles.
