I, Darren B. Cohen, declare as follows:


1. On September 3, 2013, the mark PIRATE WARRIORS was registered to NAMCO BANDAI GAMES INC. under Registration No. 4,396,987 (hereinafter “the subject Registration”).
2. On September 16, 2013, the assignment of the subject Registration from NAMCO BANDAI GAMES INC. to TECMO KOEI GAMES CO., LTD. was recorded with the Assignments Branch under Reel/Frame Number 5112/0212.
3. On May 29, 2014, the name change of NAMCO BANDAI GAMES INC. to BANDAI NAMCO GAMES INC. was recorded under Reel/Frame Number 5291/0139 against all of the applications and registrations owned by the respective parties. This recordation inadvertently and erroneously included the subject Registration, which had since been assigned to TECMO KOEI GAMES CO. LTD.
4. On July 7, 2014, the name change of TECMO KOEI GAMES CO., LTD to KOEI TECMO GAMES CO., LTD. was recorded under Reel/Frame Number 5317/0621.
5. On March 22, 2016, the name change of BANDAI NAMCO GAMES INC. to BANDAI NAMCO ENTERTAINMENT INC. was recorded under Reel/Frame Number 5755/0109 against all of the applications and registrations owned by the respective parties. This recordation inadvertently and erroneously included the subject Registration, which had since been assigned to TECMO KOEI GAMES CO. LTD., which party subsequently recorded a name change to KOEI TECMO GAMES CO., LTD., as indicated above.

6. THEREFORE, as the inclusion of the subject Registration in the name change conveyances as recorded under Reel/Frame Numbers 5291/0139 and 5755/0109 was inadvertently done in error, it is respectfully requested that the chain of title be corrected to identify the current owner of the subject Registration as KOEI TECMO GAMES CO. LTD.
