RELEASE OF SECURITY INTEREST  
IN TRADEMARKS

APICORE US LLC, a Delaware limited liability company ("Grantor"), whose address is 49 Napoleon Court, Somerset, NJ 08873, executed an Intellectual Property Security Agreement dated as of July 3, 2014 in favor of KNIGHT THERAPEUTICS INC., a Canadian corporation, as agent for the benefit of certain lenders ("Agent"), whose address is 376 Victoria Ave., Suite 220, Westmount, Quebec H3Z 1C3 (as amended from time to time, the "Security Agreement").

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Released Marks, and retransfers to Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Agent, all of Agent's right, title and interest in and to the Released Marks, the goodwill associated therewith, and all causes of action for past infringement, if any.


