IN WITNESS WHEREOF, the parties and their duly authorized representatives have caused this Assignment of Trademarks to be executed on the date and in the capacities shown below.



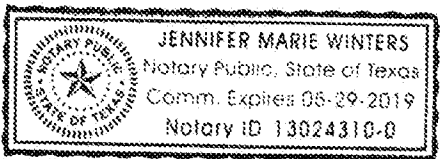

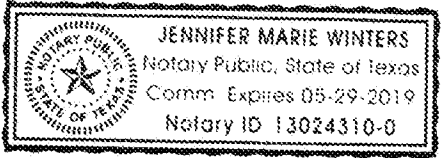
