## RELEASE OF SECURITY INTERESTS

This Release of Security Interests is made as of January 11, 2017 by Wells Fargo Bank, National Association, a national banking association ("**Secured Party**"), in favor of Ogio International, Inc., a Utah corporation ("**Debtor**").

### WITNESSETH

WHEREAS, Debtor has heretofore granted to Secured Party a security interest in certain intellectual property pursuant to that certain Credit and Security Agreement dated August 28, 2009 by and between Secured Party, as lender, and Debtor, as borrower (as amended from time to time, the "**Credit Agreement**");

WHEREAS, pursuant to the Credit Agreement, Debtor executed and delivered to Secured Party that certain Patent and Trademark Security Agreement dated August 28, 2009 (the "**Patent and Trademark Security Agreement**") and recorded with the United States Patent and Trademark Office (the "**USPTO**") against the patent filings listed therein on October 2, 2009 at REEL: 023319, Frame: 0175, and against the trademark filings listed therein on October 2, 2009 at REEL: 004073, Frame: 0081 (collectively, the "**USPTO Recordings**"); and

WHEREAS, Secured Party has agreed to release its security interests in all "**Intellectual Property Rights**" (as defined in the Credit Agreement) and other collateral and including, without limitation, the "**Patents**" and "**Trademarks**" (each as defined in the Patent and Trademark Security Agreement), and including without limitation those Patents and Trademarks listed on **Schedule A** attached hereto, and further including all goodwill associated with the foregoing, and the applications therefor and registrations thereof, and any other rights and interest it might have arising out of the Credit Agreement, the Patent and Trademark Security Agreement and/or any other "**Loan Documents**" (as defined in the Credit Agreement).


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby releases its security interests in all of the collateral covered by the Credit Agreement, the Patent and Trademark Security Agreement and/or any other Loan Documents, including without limitation the Intellectual Property and the Patents and Trademarks (including without limitation those Patents and Trademarks listed on **Schedule A** attached hereto), and further including all goodwill associated with the foregoing, and the applications therefor and registrations thereof, and any other rights and interest it might have arising out of the Credit Agreement, the Patent and Trademark Security Agreement and/or any other Loan Documents.
