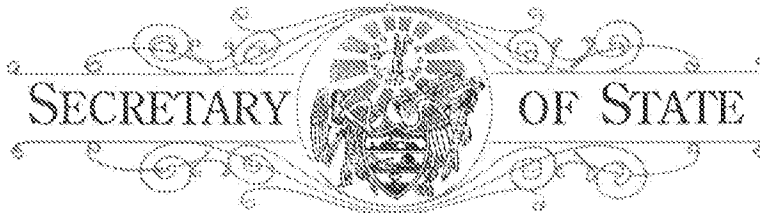

**ARTICLES OF MERGER  
OF  
SIMMONS FEED INGREDIENTS, INC.  
AND  
PRO\*CAL, INC.**

In accordance with the provisions of the Arkansas Business Corporation Act of 1987 (the "Act"), PRO\*CAL, Inc., an Arkansas corporation, and Simmons Feed Ingredients, Inc., an Arkansas corporation, desiring to effect a merger, set forth the following:

(1) The name, form and jurisdiction of incorporation for each constituent corporation are as follows:

PRO\*CAL, Inc., a corporation formed under the laws of the State of Arkansas; and

Simmons Feed Ingredients, Inc., a corporation formed under the laws of the State of Arkansas.

(2) The name of the surviving corporation is Simmons Feed Ingredients, Inc., an Arkansas corporation (the "Surviving Corporation").

(3) The merger shall become effective as of 11:59 p.m. Central time on December 31, 2016.

(4) The merger has been approved, as to each constituent corporation, as required by and in compliance with the Act, the governing statute for each corporation.

(5) The plan of merger is on file at the offices of the Surviving Corporation at 601 N. Hico, Siloam Springs, Arkansas 72761.
