Trademark Release

This Trademark Release is executed as of December 20, 2016 (the "Release"), by **ING BANK N.V., LONDON BRANCH**, as Security Agent for the Secured Parties (the "Security Agent"), for the benefit of **ZODIAC EUROPEAN POOLS SAS** (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to an Intellectual Property Security Agreement dated as of September 27, 2007 (the "IP Security Agreement"; any capitalized term used but not otherwise defined herein shall have the meaning assigned to such term in the IP Security Agreement) between the Grantor and the Security Agent, which IP Security Agreement was recorded in the U.S. Patent and Trademark Office on September 27, 2007 at Reel 3632, Frame 0297, the Grantor has granted a security interest in its right, title and interest in and to the trademarks set forth on Schedule 1 hereto (the "Trademarks") to the Security Agent, for the benefit of the Secured Parties.

WHEREAS, in connection with the satisfaction and discharge of the Secured Obligations, the Security Agent (acting on behalf of the Secured Parties) has agreed to release the security interests created under the IP Security Agreement on the terms and conditions set forth in that certain Deed of Release dated as of December 20, 2016, between the Security Agent, the Grantor and certain other parties thereto.

NOW, THEREFORE, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent (acting on behalf of the Secured Parties), hereby terminates, releases and discharges the entirety of its security interest in the Trademarks, and any right, title or interest the Security Agent may have in, to or under the Trademarks shall hereby cease and become void.

The Security Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Patents contemplated hereby.

This Release shall be governed by and construed in accordance with the laws of the State of New York (including, without limitation, Section 5-1401 of the General Obligations Law of the State of New York), without regard to conflict of laws principles that would require application of another law. This Release will be binding upon and inure to the benefit of each party and its successors and assigns.
