

Assignor agrees to execute and deliver at the request and cost of Assignee, all necessary documents, papers, instruments, and assignments in order to assign the Marks to Assignee, and to perform any other reasonable acts Assignee may require in order to vest all Assignor's rights, title, and interest in and to the Marks in Assignee, including Assignee's right to record this Trademark Assignment with the United States Patent and Trademark Office and all other trademark offices worldwide, and to provide evidence to support any of the foregoing in the event such evidence is reasonably deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.
