Pursuant to the provisions of Title 14 §14-2-1105 and §14-2-1107 of the Georgia Business Corporation Code (the "GBCC"), and Title 8, Section 252 of the General Corporation Law of the State of Delaware ("GCL"), the undersigned corporation does hereby certify as follows:

1. The name and state of incorporation of each corporation which is merging is as follows:
  - (a) GoodCents Services, Inc., a Delaware corporation ("GoodCents Services");
  - (b) GoodCents Concepts, Inc., a Georgia corporation ("GoodCents Concepts"); and
  - (c) EnerTouch, Inc., a Georgia corporation ("EnerTouch").

GoodCents Services and GoodCents Concepts shall be merged with and into EnerTouch with EnerTouch being the surviving corporation. The name of the surviving corporation is EnerTouch, Inc.

2. The Certificate of Incorporation, as amended, of EnerTouch, as in effect immediately before the mergers, shall be the Certificate of Incorporation of the surviving corporation.
3. The Agreement and Plan of Merger, dated as of December 30, 2016 (the "Merger Agreement"), by and among GoodCents Services, GoodCents Concepts and EnerTouch, has been approved and adopted by each of the aforesaid corporations in accordance with the requirements of the laws of Delaware and the laws of Georgia. 
