## ASSIGNMENT

This ASSIGNMENT, effective as of November 6, 2015, is made by and among: (i) VeriTeQ Acquisition Corporation, a corporation existing under the laws of the State of Florida, USA, having a place of business at 3333 South Congress Avenue, Suite 401, Delray Beach, Florida 33445 ("VeriTeQ"); (ii) PositiveID Animal Health Corporation, a corporation existing under the laws of the State of Florida, USA, having a place of business at 3333 South Congress Avenue, Suite 401, Delray Beach, Florida 33445 ("PAHC"); and (iii) Magna Equities I, LLC, a limited liability company organized and existing under the laws of Delaware, USA, having a place of business at c/o Magna, 40 Wall Street, New York, New York 10005 ("Magna").

WHEREAS, VeriTeQ owns the entire right, title and interest in and to the patents and patent applications listed in Attachment A hereto, as well as any continuations, continuation-in-part, divisionals, re-issues, re-examinations and extensions thereof, and any corresponding patents and patent applications in other countries (collectively, "Patent IP"); and

WHEREAS, VeriTeQ and PAHC own the entire right, title and interest in and to the trademarks and trademark registrations listed in Attachment B hereto and all goodwill associated therewith (collectively, "Trademark IP"); and

WHEREAS, VeriTeQ and PAHC (collectively, "ASSIGNORS") desire to transfer to Magna ("ASSIGNEE"), and ASSIGNEE desires to acquire from ASSIGNORS, the entire right, title and interest in and to the Patent IP, to all patents based on the Patent IP, and to the Trademark IP.

NOW, THEREFORE, for valuable consideration, the receipt and legal sufficiency of which ASSIGNORS acknowledge, ASSIGNORS hereby do assign and transfer to ASSIGNEE, its successors and assigns, the entire right, title and interest in and to:

1. The Patent IP;
2. All applications based on or claiming priority from the Patent IP, including all divisionals and continuations ("Application Family");
3. All patents which may be granted on the Patent IP and Application Family by the United States of America, its territories and possessions, and by all foreign countries, including all priority rights and all reissues thereof ("Patents");
4. The Trademark IP; and
5. The right to sue, make claims and recover damages for any past, present or future infringement, misappropriation or unauthorized use by third parties of any of the items described in 1 through 5 above, and the right to all income, royalties, damages and other payments that are now or may hereafter become due or payable with respect to any of the items described in 1 through 5 above.

ASSIGNORS agree, at the request of ASSIGNEE, to sign any and all papers reasonably needed to file and prosecute the Patent IP and Application Family, to obtain the Patents, and to perfect and vest in ASSIGNEE the entire right, title and interest in the Patent IP, Application

Family and Patents. ASSIGNORS also agree to provide assistance that is reasonably needed to prepare and prosecute the Patent IP and Application Family.






