**ABL PARTIAL TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This ABL Partial Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of December 7, 2016, by DEUTSCHE TRUST COMPANY AMERICAS, a New York bank (the “Collateral Agent”) in favor of WILTON INDUSTRIES, INC., a Delaware corporation with offices at 2240 w. 75<sup>TH</sup> Street, Woodridge, Illinois 60517 (the “Pledgor”).

W I T N E S S E T H:

WHEREAS, Pledgor entered into a certain ABL trademark security agreement dated August 30, 2012 (the “ABL Trademark Security Agreement”) with the Collateral Agent, notice of which was recorded on October 8, 2012 at the United States Patent and Trademark Office at Reel 4875, Frame 0692.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the ABL Trademark Security Agreement.

WHEREAS, Pledgor granted the Collateral Agent, under the terms of the ABL Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to Pledgor’s trademarks listed in **Schedule A** (collectively, the “Trademarks”) and all of the goodwill associated with such Trademarks.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all the Trademarks set forth in Schedule A as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademarks, and all of the goodwill associated with such Trademarks, and assigns, transfers and conveys to Pledgor any interest in such intellectual property, including the Security Interest. For avoidance of doubt, this Trademark Release only extends to the trademark properties identified on Schedule A hereto.


