## TRADEMARK PURCHASE AND ASSIGNMENT AGREEMENT

This Trademark Purchase and Assignment Agreement (the "Agreement") is made as of January 8, 2017, (the "Effective Date"), between Suzuki Motor of America, Inc., 3251 E.
