**ASSIGNMENT**

WHEREAS, Bottega Veneta International S.a.r.l., a company registered under the laws of Luxembourg, with a registered office at 124 Boulevard de la Pétrusse, Luxembourg L-2330 ("Assignor"), owns certain trademarks and/or service marks, and applications and/or registrations for such marks, as listed in Exhibit A attached hereto and incorporated herein by this reference (the "Bottega Veneta Marks"); and

WHEREAS, Assignor and Assignee have entered into that certain Transfer of Assets Agreement dated June 14, 2012 (the "Transfer of Assets Agreement"), assigning, among other things, all right, title and interest in and to the Bottega Veneta Marks and in and to the registrations and/or applications for same from Assignor to Assignee;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby sell, assign, transfer and convey unto Assignee its entire right, title and interest in and to the Bottega Veneta Marks, and to the applications and/or registrations for the Bottega Veneta Marks, together with the goodwill of the business symbolized by and associated with the Bottega Veneta Marks and the portion of the business of Assignor to which the Bottega Veneta Marks pertain, including the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Bottega Veneta Marks or the registration thereof or such associated goodwill.

Nothing in this confirmatory trademark Assignment shall alter the terms of the Transfer of Assets Agreement.
