THIS ASSIGNMENT is made on the 11th day of ^{August} ~~July~~ 2006 (this "Assignment")

BETWEEN:

- (1) Avon Property Management Co., a Michigan corporation (the "Assignor"); and
- (2) Cadillac Rubber & Plastics, Inc., a Michigan corporation (the "Assignee").

WHEREAS:

This Assignment is made pursuant to the Stock and Asset Purchase Agreement dated 19 May 2006 between Petrol Automotive Holdings, Inc. and Avon Rubber plc.

NOW, THEREFORE, IT IS AGREED:-

1 DEFINITIONS

1.1 In this Assignment:

"Trade Marks" means the registered trade marks and trade mark applications listed in the schedule to this Assignment.

2 ASSIGNMENT

2.1 In consideration of the payment of £1 (receipt of which is hereby acknowledged) the Assignor hereby assigns and transfers to the Assignee absolutely with full title guarantee all of its right, title and interest in and to the Trade Marks and all legal rights (including any unregistered and common law rights in any part of the world) and immunities (howsoever derived) attaching thereto including without limitation:

2.1.1 any copyright in the Trade Marks and all the goodwill of the Assignor's business connected with the use of, symbolised by or attaching to the Trade Marks;

2.1.2 the right to pursue or to terminate any pending trade mark application and to apply for, prosecute and obtain registered trade marks in the future in any country of the world in respect of trade marks the same as, or similar to, the Trade Marks; and

2.1.3 the right to sue for or to recover damages and other remedies in respect of any infringement of the Trade Marks, or for passing off or any similar cause of action in any jurisdiction, which may have occurred before the date of this Assignment.

3 FURTHER ASSURANCE

3.1 The Assignee shall be responsible, at its own cost and expense, for recording the assignments made under clause 2 above. The Assignor shall, at the request of the Assignee in writing and at the Assignee's expense, do and execute, or arrange for the

doing and executing of, each necessary act, document and thing reasonably within its power to implement the assignments provided for in this Assignment.

3.2 The Assignor:

3.2.1 shall at the Assignee's request and expense make available to the Assignee as soon as practicable after the date of this Assignment all files held by the Assignor relating to the applications for, prosecution of and renewal and maintenance of the Trade Marks, and shall at the written request of the Assignee request that any trade mark agent or attorney acting for the Assignor makes available to the Assignee at the Assignee's expense any such files held by the trade mark agent or attorney on behalf of the Assignor; and

3.2.2 shall, at the reasonable request of the Assignee and at the Assignee's expense, provide any assistance or co-operation reasonably necessary to the Assignee in connection with the conduct of any proceeding or other action taken in connection with opposition to the registration of or application to revoke any Trade Mark or in connection with any infringement or suspected infringement of the Trade Marks or to enforce any unregistered or common law rights assigned under clause 2 above,

provided always that the Assignor shall not be obliged to provide any assistance or co-operation as set out in clauses 3.2.1 and 3.2.2 above any later than 2 years after the date of this Assignment.

4 **GENERAL**


This Assignment may be executed in one or more counterparts each of which, when executed, shall constitute an original and all of which together shall constitute one and the same instrument.

5 **GOVERNING LAW**


5.1 This Agreement shall be governed by and construed in accordance with the laws of the state of New York.
