RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is dated as of January 25, 2017 by UBS AG, STAMFORD BRANCH, in its capacity as collateral agent for the Lenders (together with any successors and permitted assigns thereto in such capacity, the "Agent"), in favor of TRAVEL LEADERS GROUP, LLC, NEXION, LLC, , TZELL TRAVEL, LLC and TRAVEL LEADERS NETWORK, LLC (as successor in interest to TRAVEL LEADERS FRANCHISE GROUP, LLC and VACATION.COM, LLC) (individually, a "Pledgor", and, collectively, the "Pledgors"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

WHEREAS, the Pledgors and the Agent entered into that certain Security Agreement, dated as of December 5, 2013 (the "Security Agreement"), pursuant to which Pledgors executed and delivered to the Agent that certain Trademark Security Agreement, dated as of December 5, 2013 (the "Trademark Security Agreement"), for recordation with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 5, 2013 in Reel 5168, Frame 0334;

WHEREAS, pursuant to the terms and conditions of the Security Agreement and the Trademark Security Agreement, each Pledgor granted to the Agent, on behalf of and for the ratable benefit of the Secured Parties, a lien on and security interest (the "Security Interest") in all of such Pledgor's right, title and interest in, to and under the Trademark Collateral (as defined below);

WHEREAS, pursuant to a certain Trademark Assignment, recorded with the United States Patent and Trademark Office on January 23, 2017, TRAVEL LEADERS NETWORK, LLC assigned its entire title, rights and interest in and to certain Trademark Collateral to TRAVEL LEADERS GROUP, LLC, and

WHEREAS, the Agent desires to terminate and release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

Section 1. Definitions. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

The term "Trademark Collateral," as used herein, shall mean (i) the Trademarks of such Pledgor listed on Schedule 1 hereto, (ii) all Goodwill associated with such Trademarks, and (iii) all Proceeds of any and all of the foregoing (in each case, (i), (ii) and (iii), other than Excluded Property).

Section 2. Release of Security Interest in Trademark Collateral. The Agent, on behalf of the Secured Parties, hereby (i) terminates the Trademark Security Agreement; and (ii) terminates, releases and forever discharges the Security Interest in the Trademark Collateral, and retransfers and reassigns to each Pledgor any right, title or interest of the Agent in, to or under the Trademark Collateral.

SECTION 3. Recordation. The Agent hereby authorizes Pledgors or any of their authorized representatives to file this Release with the United States Patent and Trademark Office or any other applicable governmental office. The Agent hereby further authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

SECTION 4. Further Assurances. The Agent hereby agrees to execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by Pledgors, at Pledgors' expense, to fully effectuate the purposes of this Release.

SECTION 5. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.

SECTION 6. Counterparts. This Release may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
