Assignor agrees, upon the request of Assignee, to execute any necessary and proper oaths or affidavits relating to the SONIC VORTEX mark as required for the registration, renewal, validation of use or status or extension that Assignee, which in the opinion of counsel for Assignee, may deem necessary or expedient.

3. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any and all trademark registrations which are or may be granted, renewed or reissued for the SONIC VORTEX mark, to the Assignee and hereby covenants that Assignor has


full right to convey the entire interest herein assigned, and that Assignor has not executed, and will not execute, any agreements in derogation thereof.
