## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS** (this "Termination"), dated as of January 13, 2017, is made by Goldman Sachs Lending Partners LLC as grantee (in such capacity, the "Grantee"), in favor of REDI Tech, LLC, a Delaware limited liability company (the "Grantor"). Unless otherwise defined herein or the context otherwise requires, terms used in this Termination shall have the meanings assigned to such terms in the Security Agreement (as defined below). For the purposes of this Termination, "Trademark Collateral" shall have the meaning assigned to such term in the Security Agreement (as defined below) and shall include, without limitation, those registrations and applications set forth on Schedule A hereto.

**WHEREAS**, pursuant to that (i) certain Guarantee, Pledge and Security Agreement, dated as of September 2, 2015 (as it may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by, among others, the Grantor and the Grantee and (ii) that certain Grant, dated as of September 2, 2015 executed by the Grantor in favor of the Grantee (the "Grant"), the Grantor granted to the Grantee a security interest in and continuing lien on all of the Grantor's right, title and interest in, to and under the Trademark Collateral; and

**WHEREAS**, the security interest in the Trademark Collateral granted by the Grantor to the Grantee under the Grant was recorded at the United States Patent and Trademark Office on September 9, 2015 at Reel 5619 and Frame 0240; and

**WHEREAS**, the Grantee has agreed to irrevocably terminate, release and discharge its security interest and lien on all of the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities of the Grantor secured by the Trademark Collateral pursuant to the Security Agreement and the Grant, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby agrees as follows:


1. The Grantee, without representation, recourse or warranty of any kind, hereby irrevocably terminates, releases and discharges all of its mortgages, liens, and security interests in all of the Grantor's right, title and interest in, to and under the Trademark Collateral and hereby reassigns any and all such right, title and interest (if any) that the Grantee may have in the Trademark Collateral to the Grantor.

2. The Grantee authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Termination.

3. THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TERMINATION SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF (OTHER THAN SECTIONS 5-1401 AND 5-1402 OF THE NEW YORK GENERAL OBLIGATIONS LAW).

**IN WITNESS WHEREOF**, the Grantee has caused this Termination of Security Interest in Trademarks to be duly executed as of the date first set forth above.
