RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARK RIGHTS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this “Release”) is made as of January 6, 2017 (“Effective Date”) from Credit Suisse AG, a national banking association, located at Eleven Madison Avenue, New York, NY 10010, in its capacity as Administrative Agent (the “Agent”) in favor of Eliot Management Group, LLC, a Utah limited liability company, located at 100 Throckmorton Street Suite 1800, Fort Worth, TX 76102 (the “Grantor”). All capitalized terms used but not defined herein have the meanings provided or provided by reference in the Trademark Security Agreement (as that term is defined below).

WHEREAS, pursuant to the First Lien Guarantee and Collateral Agreement dated as of October 12, 2012, in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the “First Lien Guarantee and Collateral Agreement”), Grantor pledged and granted to the Agent for the benefit of the Agent and the Lenders a continuing security interest in certain collateral, including Trademarks;

WHEREAS, pursuant to that certain Grant of First Lien Security Interest in Trademark Rights, dated as of October 12, 2012 (the “Trademark Security Agreement”) between Agent and Grantor, Grantor, by reference to the First Lien Guarantee and Collateral Agreement, reaffirmed its intent to grant the security interest to the Agent specifically in certain Collateral (as that term is defined in the Trademark Security Agreement); and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 24, 2012 at Reel 4888, Frame 0004;


NOW, THEREFORE, without recourse, representation or warranty and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels and releases its security interest in the Collateral, including the Collateral set forth on Schedule A hereto, and any right, title or interest of the Agent in such Collateral shall hereby cease and become void.

The Agent shall take all further actions, and provide to the Grantor, its successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor and at Grantor’s expense to more fully and effectively effectuate the purposes of this Release. The Agent hereby authorizes and requests that the Commissioner for Patents and Trademarks of the United States Patent and Trademark Office record this Release.


