**ASSIGNMENT OF TRADEMARKS**

**THIS ASSIGNMENT OF TRADEMARKS**, effective as of [●], 2016 (this “**Assignment**”), is made by Charles Smith Wines LLC, a Delaware limited liability company having its principal place of business at 35 South Spokane Street, Walla Walla, Washington 99362 (“**Assignor**”), and CBZ LLC, a Delaware limited liability company, having its principal place of business at 207 High Point Drive, Building 100 Victor, New York 14564 (together with its successors and assigns, the “**Assignee**”).

Assignor has adopted, owns and is using certain trademarks relating to the Brands for which Assignor owns the trademark applications and/or registrations and all common law rights associated therewith, that are listed in **Schedule A** attached hereto and incorporated herein by reference (collectively, the “**Trademarks**”).

Assignor has agreed to assign to the Assignee all of the rights, title, and interests of Assignor in and to the Trademarks, and Assignee has agreed to accept said assignment.

For Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers, and conveys to Assignee, and Assignee, as the successor to the portion of the ongoing and existing business to which the Trademarks pertain, hereby accepts from Assignor, all of the rights, title, and interests of Assignor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, with the right to recover for damages and profits and all other remedies for past infringements thereof.

This Assignment shall be governed by and interpreted and enforced in accordance with the Laws of the State of New York, without giving effect to conflicts of law principles. This Assignment may be executed in two or more counterparts, each of which shall be deemed an original. This Assignment and any counterpart so executed shall be deemed to be one and the same instrument. A signed copy of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

This Assignment is given pursuant to the terms of that certain Asset Purchase Agreement, dated as of October 5, 2016, by and among Assignor, K Vintners, L.L.C., a Washington limited liability company, Charles Smith, an individual, and Constellation Brands, Inc., a Delaware corporation (the “**Purchase Agreement**”). Pursuant to Section 13.2 of the Purchase Agreement, CBI has assigned to Assignee the right to purchase and receive the Trademarks. The terms and conditions of the Purchase Agreement are incorporated herein by reference. All capitalized terms used herein but not otherwise defined shall have the same meanings as set forth in the Purchase Agreement. In the event of a conflict or inconsistency between the provisions of this Assignment and the provisions of the Purchase Agreement, the provisions of the Purchase Agreement will prevail.



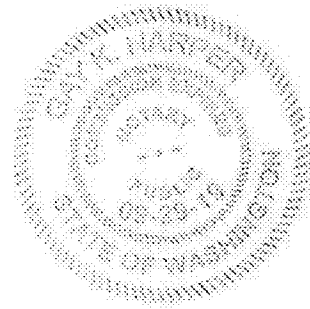
