**TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS**  
("Release"), dated as of the <sup>28<sup>th</sup></sup> day of December 2016, by **WEBSTER BUSINESS CREDIT CORPORATION**, a New York corporation ("WBCC"), having an office at 360 Lexington Avenue, New York, NY 10017 and **M.W. SAMARA LLC**, a New York corporation ("MWSL"), having its principal executive offices at 390 Fifth Avenue, New York, NY 10018.

**WITNESSETH:**

**WHEREAS**, pursuant to the parties' August 19, 2013 Security Agreement ("Security Agreement"), MWSL granted to WBCC Security Interests ("Security Interests") in certain collateral as defined in said Security Agreement, including the U.S. trademark registrations listed in Exhibit A ("Trademarks") hereto:

**WHEREAS**, the Security Interests were recorded in the United States Patent and Trademark Office at reel/frame 5095/0822; and

**WHEREAS**, WBCC and MWSL have agreed to retire the parties' obligations under the Security Agreements and WBCC wishes to release its Security Interests in the U.S. trademark registrations listed in Exhibit A hereto;

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. WBCC hereby releases its Security Interests and any right, title and interest which it may have in and to all Trademarks listed on Exhibit A hereto, does hereby release and terminate all liens and security interests in and to the Trademark


collateral which were granted, pledged and assigned to WBCC, including the right to sue for past, present and future infringements thereof.

2. The parties hereto agree that at any time and from time to time, upon the reasonable written request of another party hereto, such party will promptly execute and deliver all further instruments and documents, and take all further action, that may be necessary, or reasonably desirable, or that such other party may reasonably request, in order to effect the purposes of this Release.

3. This Release may be filed by WBCC or MWSL with the United States Patent and Trademark Office without further notice.
